While most of the content in this edition is celebratory, I want to spend my column making you aware of potential actions by the Centers for Medicare and Medicaid (CMS) that can significantly impact VNA and the services we provide. CMS continuously works toward curbing Medicare spending through a variety of paths that impact multiple provider types. The most recent relates to Home Health reimbursement. The proposed payment rule for 2023 includes a potential cut of nearly 8%, which will reduce our Home Health revenue approximately \$160,000.



VNA appreciates the current economic environment impacting everyone at this time. However, we also recognize you support the agency and the important work we do. For that reason, I'm making you aware of how you can help. Pending legislation, "The Preserving Access to Home Health Act of 2022" (S. 4605/H.R.8581) is under consideration by Congress. The bill would prevent proposed cuts from taking effect prior to 2026, which would allow CMS to re-examine its approach to calculating necessary budget adjustments. Additionally, Home Health agencies would be afforded more time to move past the financial impact of the COVID pandemic. Past experience indicates grassroots efforts are effective with our representatives. Our national association has created a simple online

My celebration with this message is the gratitude VNA feels for the continuous support you provide.
